

2009/2010 Gold Coast and Gulf Coast Camping Information

While the Florida State Fairgrounds does not offer camping for the general public, the Florida State Fair Authority does provide camp sites for the convenience of participants in events being held on the grounds. To reserve your camping space for the Gold Coast - Gulf Coast Quarter Horse Shows, please contact the Equestrian Office at 813-740-3500, 813-621-7821 x 379, or by email at: paytonr@doacs.state.fl.us.

The camping fee for a full hook-up with a 30 amp spot is \$40.00 per night, and full hook-up with a 50 amp spot is \$50.00 per night (limited quantities).

When full hook-up slots are sold out, there is limited parking for self-contained (those possessing sewage retention capabilities) units. Any unit in this area MUST have sewage retention – We will TRY to accommodate your ELECTRIC, and WATER needs but there are no guarantees. Your credit card will be charged if an individual is found dumping; WHICH INCLUDES GRAY OR BLACK WATER on the ground (see rule #10).

Arrangements can be made to have you sewer tank pumped out by leaving payment and campsite number with Camping Attendant(s) at South Campground space #92. There will not be any on site propane deliveries this year.

Campground Rules:

1. Spaces are assigned upon arrival and special requests will be honored if possible. Guests are to use their assigned space unless given permission to relocate by campground management.
2. Only one electrical hook-up is provided per campsite. Use of additional hook-ups will result in the assessment of additional campsite fees. Each standard hook-up is 30 amp (110 volt). 50 amp (220 volt) hook-ups are only on a limited first-come first-served basis with NO GUARANTEES of availability.
3. Full payment is required with application. Acceptable payment must be in the form of a major credit card (American Express, MasterCard, and VISA). Personal checks cannot be accepted. Credit cards will be processed upon arrival.
4. Due to high demand, reservations are mandatory. Please call 1-813-740-3500 in advance to verify availability.
5. All pets will be regulated by the Hillsborough County Leash Law, and all dogs must be on a leash or caged while on the fairgrounds. Failure to comply with regulations may result in your being asked to vacate the premises without a refund. All guests must be responsible for the cleanup of all pet waste.
6. All campground guests should remain in authorized areas, (which is limited to the Equestrian Center) and are not permitted beyond the barns and rings.
7. Livestock is not permitted to be walked, ridden, or housed in the campground area.
8. Vehicles are to be parked in their assigned campsite only.
9. Tents and Awnings are not permitted.
10. Dumping in non-designated areas will result in a \$500.00 fine and/or eviction of person(s) and their property including but not limited to horses, equipment, and vehicles from FSFA property. FSFA will not be responsible for lost stall or entry fees upon eviction.
11. Any guest operating a motorized vehicle: including but not limited to a golf cart, scooter, car, or truck must be a licensed and insured driver.
12. NO charcoal grilling or open flames; all grills must be gas or electric.

The Florida State Fair Authority is not responsible for lost, stolen, or damaged property.

We recommend you keep your vehicles locked.
